MISSION

The Vermont Premier League aims to expand opportunities for the entire Vermont soccer community with an option that provides an accelerated timeline on schedule release; more consistent scheduled game times; prioritization of families and coaches and developmentally appropriate matchups



PURPOSE - WHY DID THE VPL FORM?

LESS LEAGUE GAMES

5 Game Schedule - less league games to incorporate around tournaments/events

SUNDAY GAMES

Mostly played on Sunday's to keep game dates predictable for families



CENTRALIZED LOCATIONS

Keeping one club scheduled in a geographic area per week for families/refs/coaches

SMALLER BRACKETS

Smaller brackets that are developmentally appropriate

PURPOSE - WHY DID THE VPL FORM?



YEAR ROUND CLUBS

- Organize earlier
- Train and pay year round
- More resources/flexibility
- Participate in more events (less league play)
- Paid staff



SEASONAL CLUBS

- Organize after the new year
- Train and play primarily in one season
- Participate primarily in league play and less large events
- Volunteer staff

2 REQUIREMENTS

Requirements for VPL Clubs

MEMBER REQUIREMENTS

- Ability to organize and submit teams for application January 1st each year
- Must have at least 3 teams in their greater club (note: overall club size, not member teams in VPL)
- Willingness to travel to central location in Chittenden or Washington County
- Club must have been a VSA member for at least 3 years
- Club must be in good standing
- Club must have a board of directors
- Club must have a team with standard of high performance to provide appropriate competition level
